

## ISS SPOTTER, autonomous security-drone solution: Delta Drone and the PROTEC group sign a partnership and distribution agreement

For the opening of the APS Security Trade Show held from 1 to 3 October at the Palais d'exposition, Porte de Versailles in Paris, Delta Drone and the PROTEC group announces the signature of a major distribution agreement concerning the ISS SPOTTER autonomous-drone solution developed by Delta Drone and its subsidiaries PIXIEL and DPS.
